## Contemporary Art Tasmania Members' Exhibition 2015

Contemporary Art Tasmania is now calling for artwork for the 2015 Members' Exhibition. To express your intention to participate, fill out the submission form and return it by Friday 6 November 2015

**ELIGIBILITY/CONDITIONS** You must be a current member of Contemporary Art Tasmania to submit work. Become a member at [www.contemporaryarttasmania.org/membership](http://www.contemporaryarttasmania.org/membership) or visit the CAT office.

One artwork per member.

Installed works must not exceed 100cm in any dimension (delivered works exceeding this limitation may be omitted from the exhibition).

Due to installation constraints, artworks that are complicated, require the loan of Contemporary Art Tasmania equipment or are time-consuming to install must be negotiated with staff prior to delivery. (or they may be omitted from the exhibition).

Artwork must be delivered to Contemporary Art Tasmania between November 18 - 20 2015.

Artwork must be available for the full duration of the exhibition and cannot be collected until the designated collection period.

Clear and detailed hanging instructions must accompany the artwork. While every effort will be made to comply with the artists instructions, Contemporary Art Tasmania reserves the right to hang work as it deems appropriate.

Artwork which is hazardous to the public or does not comply with the Australia Council for the Arts document: *Protocols for Working with Children in Art (December 2008)* will not be exhibited.

Artwork must be collected from Contemporary Art Tasmania no later than 8 January 2016. If you foresee difficulty in collecting your work by this time, please contact us to make alternate arrangements. If the artwork has not been collected by this time and alternative arrangements have not been made, Contemporary Art Tasmania may, after having made all reasonable efforts to notify the artist, return the artwork to the artists at their expense or dispose of it.

**Deliver artwork** (with hanging instructions) **18 - 20 Nov 2015**  
Exhibition opening from **6pm Friday 27 Nov 2015**  
Last day exhibition open to the public **Sunday 13 Dec 2015**  
**Collect** your work on **15 Dec - 8 Jan 2015** (note that the office and gallery closed between 24 Dec and 3 Jan inclusive).
